A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK OF THE CITY OF COLBY, KANSAS, TO EXECUTE A CERTAIN CONTRACT BETWEEN RURAL FIRE DISTRICT #4 OF THOMAS COUNTY, KANSAS, AND THE CITY OF COLBY, KANSAS, TO PROVIDE EMERGENCY FIRE CALL PAGER AND DISPATCH COMMUNICATIONS SERVICES AND REPEALING RESOLUTION NO. 1040

BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

SECTION 1. That the Mayor and City Clerk of the City of Colby, Kansas, are authorized to execute on behalf of the City, the contract to provide emergency fire call pager and dispatch communications services to Rural Fire District #4, Thomas County, Kansas, a copy of the contract being attached hereto and made a part hereof as if fully set out.

EMERGENCY COMMUNICATIONS AGREEMENT

THIS AGREEMENT, made and entered into effective January 1, 2017, by and between:

The City of Colby, Kansas, hereinafter referred to as “**CITY**” and **Rural Fire District #4**, hereinafter referred to as “**RFD #4.**”

WHEREAS, **RFD #4** wishes to enter into a contract with the **CITY** to provide emergency fire call pager and dispatch communications services to **RFD #4** according to the terms and conditions hereinafter set out:

NOW, THEREFORE, IT IS AGREED BY THE PARTIES AS FOLLOWS:

1. This Agreement shall be for the period beginning January 1, 2017 and ending December 31, 2019.
2. **RFD #4** shall provide and install at its sole cost and expense all pager and communications equipment necessary for the **CITY** to provide the services required by this contract.
3. The **CITY** shall provide 24-hour-per-day emergency fire call pager and dispatch communications services to **RFD #4** as needed.
4. For and in consideration of the **CITY** furnishing the services, **RFD #4** agrees to pay to the **CITY** the sum of **One Hundred Dollars (\$100.00)** to be **paid annually**.

IN WITNESS WHEREOF, the parties have entered into this contract effective the date shown above.
